Through extensive and rigorous quality control testing, UltraFlora guarantees the highest quality of purity (free of contaminants), potency, and scientifically formulated probiotic formulas that contain genetically identified strains with established health benefits for clinically reliable outcomes* .

Ensuring Purity, Reliability, and Quality

- Certificate of Analysis required from all suppliers
- Testing for contaminants, purity, and genetic strain ID upon receipt of raw materials
- Testing for total viable count using scientifically validated methodology
- Strains have been shown to resist acid, bile and pancreatin digestion allowing survival through the digestive tract for colonization
- To help maintain probiotic viability through expiration, water exposure is limited:
 - Testing for low water activity during manufacture
 - Controlled humidity and temperature during production, packaging & storage to limit exposure to water in air
- Testing for stability under storage conditions, including refrigeration, ambient, and high heat temperatures
- Guaranteed potency/CFUs (Colony Forming Units) through date of expiration:
 - Manufactured, stored, and transported under refrigeration to ensure live and healthy probiotics

Additional Testing for Possible Contaminants

- Total Yeast and Mold Count
- Staph (*Staphylococcus aureus*)
- Salmonella species
- E. coli (*Escherichia coli*)
- Other bile-tolerant harmful bacteria (including Yersinia, Klebsiella and Shigella)

All UltraFlora products are gluten free. To ensure that they fully comply with FDA standards, each product goes through a strict process, including:

- Testing every new product upon the start of production
- Strict controls to avoid cross-contamination
- Rotational testing protocol including ongoing ELISA quantitative immunoassay testing on all products
